Additional requirments

- Each contractor may submit only one offer.
- Offer should contain proposed execution date.
- Pricing should be submitted in the net values.
- Offer should contain contractor information such as name and address.
- Offer should be valid for the minimum of 30 days.
- All expenses and risks related to the compilation, preparation and submission of an offer, as well as the participation in inquiry proceedings, should be covered by the contractor.
- Offer submission is unambiguous with the acceptance of all terms of the proceedings.
- Contractors are denied any demands regarding return of the costs of the preparation of an offer as well as the participation in the proceedings.
- The ordering party does not allow making protests, appealing or using any other forms of legal protection from the decisions, conclusions, actions or abandonments on the site of the ordering party, regarding choosing of an offer, placing order or cancelling the proceedings.
- The ordering party reserves the right to cancel the proceedings, waive the conclusion of the contract and not to place an order, regardless informing the contractor about choosing his offer. Waiving the conclusion of the contract may not be basis for demand of return of the costs of preparation of an offer and the participation in the proceedings.
- The ordering party may demand additional explanations, regarding contents of an offer, from the contractor in the process of the evaluation of an offer. If offer does not contain all required components, the ordering party may, in justified cases, call of the contractor to complete it. The ordering party may, in justified cases, correct any obvious mistakes in the contents of an offer, including writing errors, calculation errors (taking into account any

accounting consequences of those corrections), as well as any other errors making such an offer incompatible with the inquiry. Such corrections may not change an offer in any significant way and the contractor must be informed about such corrections immediately. The contractor has 3 days for any objections regarding such changes. If the contractor file an objections in 3 days period his offer will be rejected.

- Only the offers delivered in appointed time, fulfilling the order subject and consistent with the conditions and requirements stated in present inquiry will be taken into account. The ordering party will not consider any offers inconsistent with description of the offer subject.

- Penalties -0.1% of the order amount for each day of delay.

COB – net price offered by the contractor

Execution time:

Where:

TD – number of points awarded to the contractor regarding ,, execution time" criteria.

TND – shortest period of time for the delivery, counted in days, for the rejected offers.

TOB – delivery time offered by the contractor.

Maximum number of pints awarded to the contractor, regarding "execution time" criteria, amounts to 40 points (40% of total available points).
